Port Blakely Mills & Milltown

This survey is a part of a comprehensive cultural management plan for Port Blakely Mill Company, and is based on an Historic American Buildings/Historic American Engineering Report format. This plan includes the services of archaeologists, biologists, botanists, hydrologists, planners and architects.

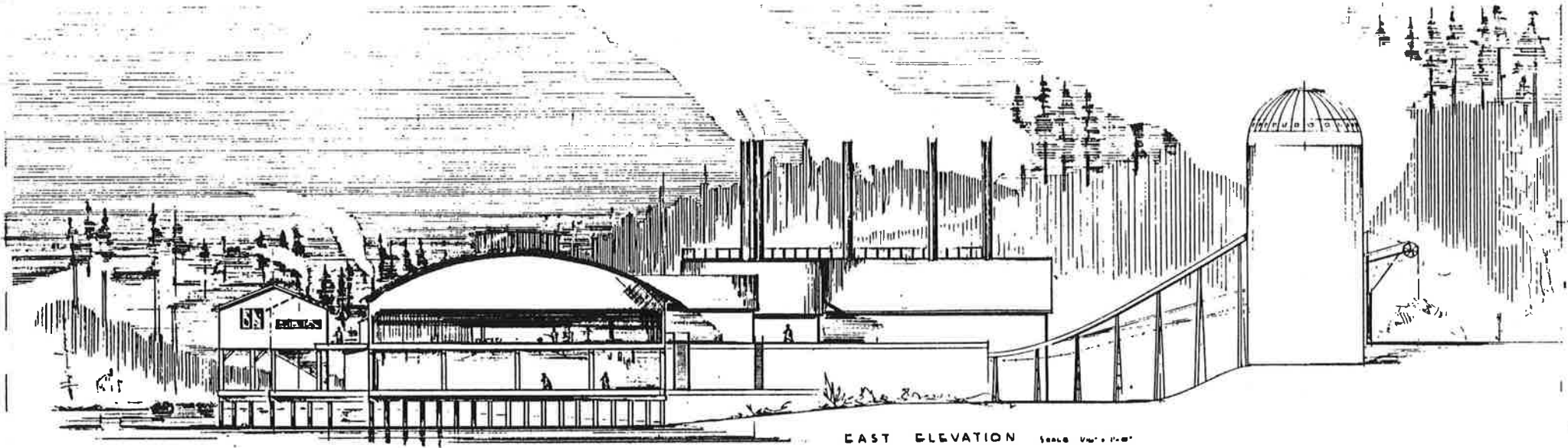
Port Blakely had been an important and unique community in the period of the lumber industry's growth in the Northwest (a succession of three mills, one considered "the largest sawmill in the world" in its day), highlighted by the sailing ships of the sea-trade epoch (square-riggers, four and five masted schooners).

Extensive research was done. Only one skeletal part of the third mill still exists, and but one of the milltown dwellings remains in relatively unaltered condition. These were measured, and record drawings were made.

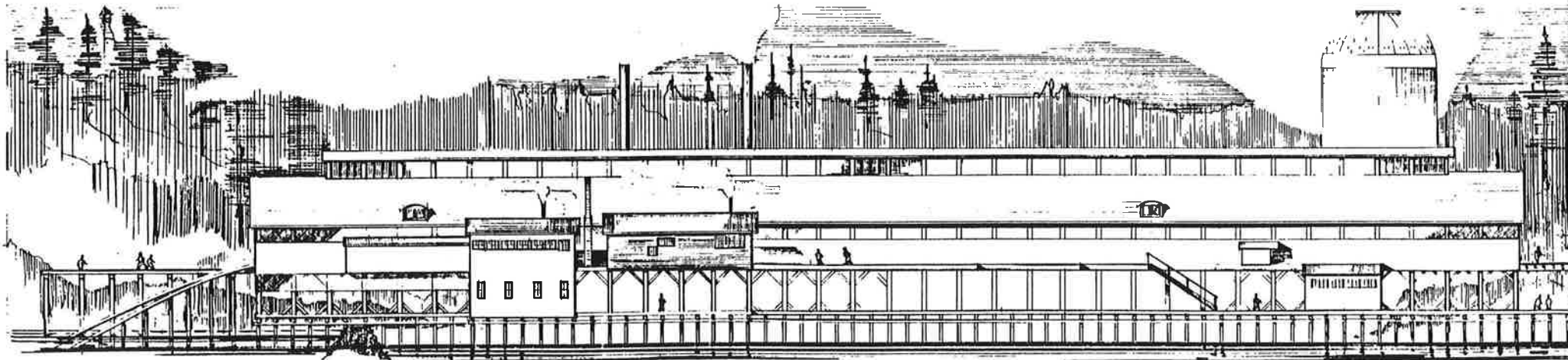
Additional significant buildings (the second mill, company store, hotel, school, lodge hall, church, the Renton residence and the Cambell house) were identified and recreated from historic photographs, Sanborn maps, and so on. Fifteen drawings resulted from this effort, along with a composite site map indicating the rise and decline of this community.

These drawings were reduced and bound into the survey along with their descriptions, photographs of these and other buildings, and a summary of the industrial, social and economic history of the site. This resulted in a 104 page survey, including an analysis of factors to be considered.

An important goal of this work is to provide a sense of the community's valuable heritage so that architects, planners and decision-makers might have an understanding and appreciation to guide their search for compatible design solutions.



EAST ELEVATION SCALE 1/16" = 1'-0"



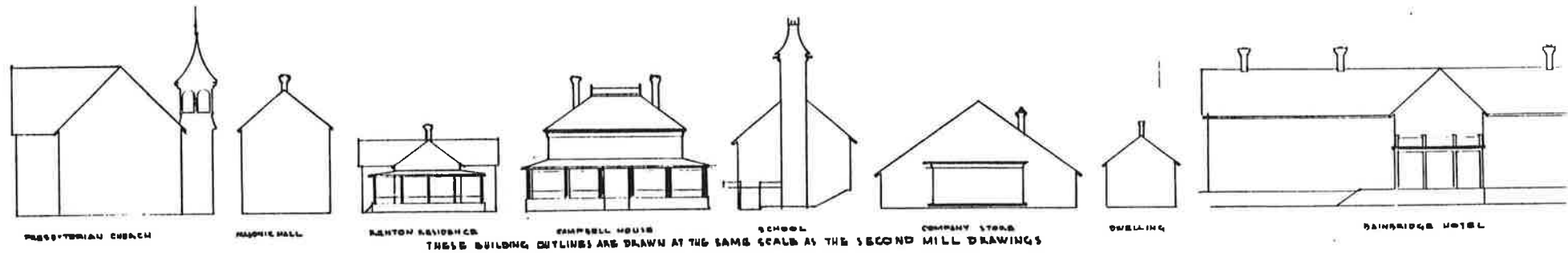
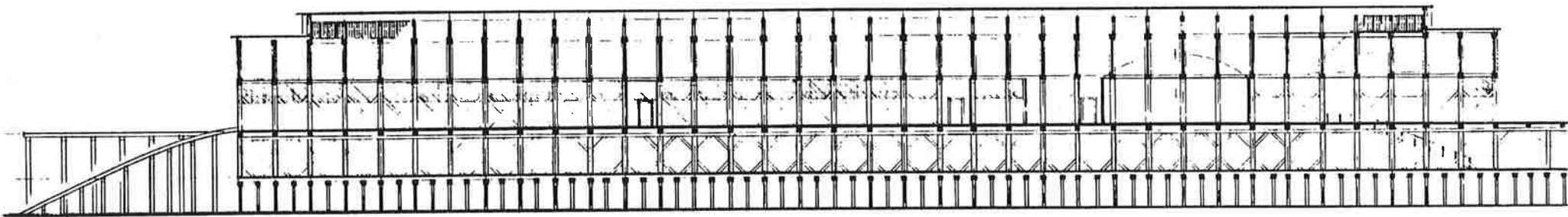
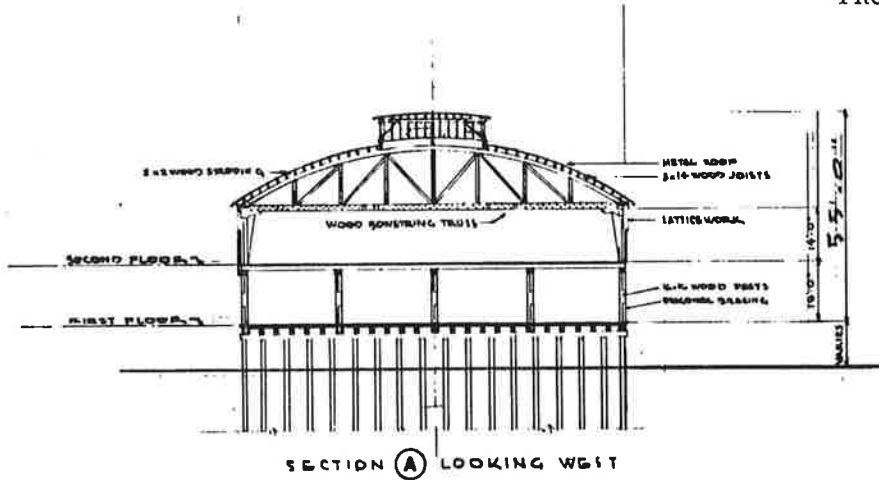
SOUTH ELEVATION SCALE 1/16" = 1'-0"

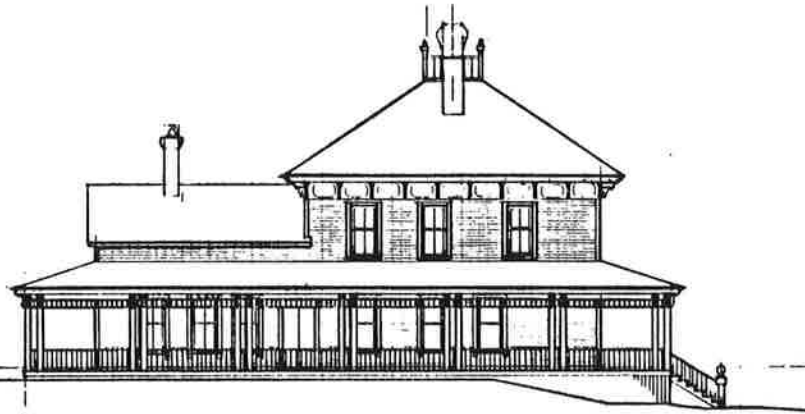




THESE BUILDING OUTLINES ARE DRAWN AT THE SAME SCALE AS THE SECOND MILL DRAWINGS

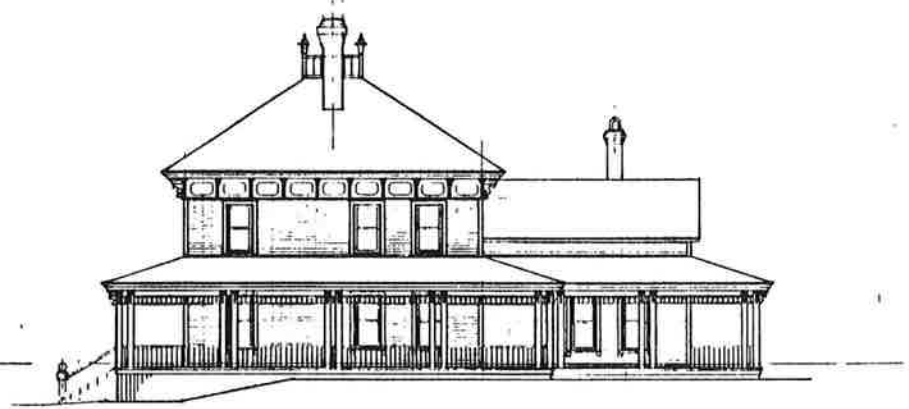

E.I. DuPont de Nemours & Co. Inc. Explosive Works, Dupont, WA

The survey was a part of a comprehensive cultural management plan. Its intent was to inventory the buildings/facilities and describe and analyze significant buildings on the site from start of construction in 1906 until DuPont's termination in 1976. It delineates the processes and circulation of materials. A composite site plan was prepared from blueprints of different periods showing the relationship of six functional areas. A search revealed blueprints of several no longer extant buildings. Elevations and sections were drawn of two different nitroglycerin nitrating and separating plants. Photographs of several significant buildings were accompanied by descriptions.

City of Tacoma Power Plant No. 2

This survey consisted of research, tours of the site, description of the buildings in relation to their candidacy for Historic Register nomination. The main building, built in 1931, is a brick structure with large semi-circular arches. In 1952 an international style addition was constructed, and in recent years an assembly of various exposed pipe, stacks, and so on, surrounded the building.

LaGrande Powerhouse, Alder, WA

Built in 1912, this brick structure is located in a deep ravine. A 1945 concrete addition dominates the design. As in the Tacoma Power Plant No. 2, an evaluation was made as to the significance of the complex.

Hops Barn, Puyallup Valley, WA

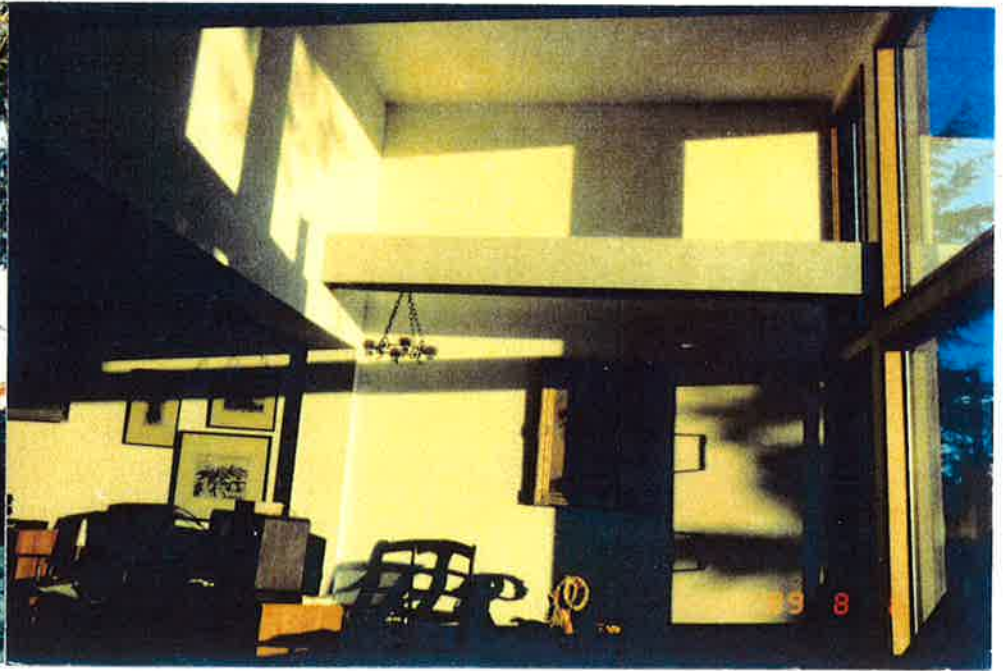
Research of the hops industry revealed that the Puyallup Valley around 1880 was the hops capital of the world. The barn in question, one of four hops barns still existing in Western Washington, was in dilapidated condition. A comparison with a nearby hops kiln on the National Register was made, along with an analysis resulting in an enumeration of options for preserving the structure. A measured drawing was made to illustrate its operation and its significant features.

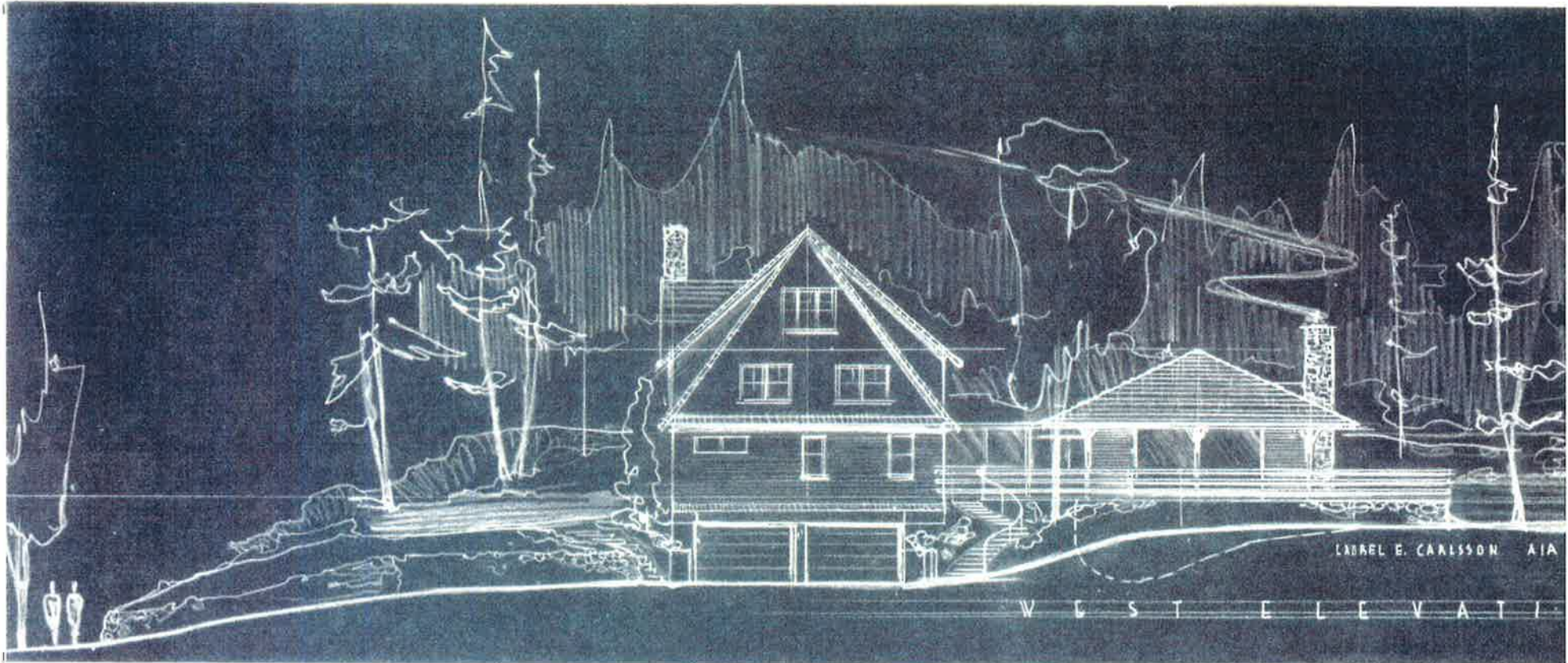
