Project Summary

In 2016 the legislature passed HB 2637, creating a state historic cemetery capital grant program within the Department of Archaeology and Historic Preservation. Grants can be used for construction, rehabilitation, or renovation that preserves the historic character, features, or materials of a decaying or abandoned cemetery. There are more than 250 cemeteries that have had fiscal issues resulting in limited care or even abandonment. The grants will assist with protecting the integrity of the historic cemetery and funding necessary improvements and rehabilitation. The agency is requesting \$515,000, similar to the Heritage Barns program, as the expectation is that many requests will be small. No request can exceed \$50,000. The agency assumes that up to 20 or more cemeteries could receive grant assistance. Provide answers to the following questions, which will inform decision makers about the proposed project.

Project Description

Identify the problem or opportunity addressed. Why is the request a priority? (Numbers not served, students without classrooms, budget savings, safety improvements, history, and other backup necessary to understand the need for the request.)

Washington State has over 1800 historic cemeteries and burial sites. Due to burial alternatives, particularly cremation, cemeteries have seen a drastic decline in revenue across the nation and in the state of Washington. Over 80% of "burials" are cremations as opposed to in-ground interments resulting in a loss of operating revenue for existing cemeteries. The lack of operating funds has resulted in the loss of care budgets for many small and large community cemeteries and as a result cemeteries are struggling to maintain the condition of their cemetery. We have seen cases, such as in Lewis County, where privately owned cemeteries are being abandoned as they are no longer fiscally viable. These small grants will assist historic cemeteries with small maintenance activities not to exceed \$50,000. There is no match required. Grants can be used for construction, rehabilitation, or renovation that preserves the historic character, features or materials of the cemetery. Grant recipients must maintain the cemetery for 10 years.

What will the request produce or construct (i.e., design of a building, construction of additional space, etc.)? When will the project start and complete? Identify whether the project can be phased, and if so, which phase is included in the request.

The project is intended to benefit the public by preserving outstanding examples of the state's historical heritage, enabling historic cemeteries to continue to serve their communities, and honoring the military veterans buried within them.

How would the request address the problem or opportunity identified in question #1? What would be the result of not taking action?

The grant would be able to help small historic cemeteries suffering from fiscal issues with costs associated with their care and maintenance. Currently there are more than 250 historic cemeteries that are threatened that the grant will help to preserve and it is anticipated that approximately 20 or more historic cemeteries could be assisted through the grant program. Historic cemeteries are an important feature of Washington's diverse heritage. In addition to marking the final resting places of our ancestors and many of the state's veterans, they yield information about our state's social, religious, artistic, and cultural heritage. The consequences of not creating the state historic cemetery capital grant program will be a continuation of the potential for the State's valuable historic cemeteries to fall into decay with little or no care and maintenance being performed. Failure to help subsidize the costs of these small historic cemeteries could even result in the abandonment of these cemeteries.

Communities statewide would benefit from the grant program and it is anticipated that 20 or more historic cemeteries across the state could receive funding.
