

 KNOW ALL MEN BY THESE PRESENTS, that Thornton Lodge No. 100 F. O. O. F. a corporation duly organized under the laws of the State of Washington, came in its lawful and proper name, having first and foremost been a club for country purposes, to be known as the THORNTON 100 F. O. O. F. CEMETERY, situate in Sec. 23, T. 15 N., R. 43 E. W. 1, in Whitman County, State of Washington, more particularly described as follows, to-wit: Commencing at a point from whence the NW Cor. of Sec 23 bears S. 87° 56' 18" W. 125.11 feet; thence S. 17° 50' E. 484.71 feet; thence S. 17° 50' W. 125.11 feet; thence N. 72° 40' W. 484.71 feet; to the place of beginning, containing 1253 Acres.

1253 Acres subject to the public for Cemetery purposes as indicated on this plan, which shows the widths of streets and lots of lots in said Cemetery.








Niche Is Found in Modern Shop

"After 10 years, it's still always like Christmas when a new shipment comes in," Joel E. Ferris III says.

A young man who obviously enjoys his work, Ferris and his wife own Joel, Inc., dealing in contemporary furniture, gifts and specialties. Ferris says that a high-fashion shop does not depend on the high-income group for its customers. Good modern furniture is not ostentatious, he says, and it often is hard for the layman to tell whether a particular piece looks "expensive" or not.

Schoolteachers, Ferris says, are some of his most discriminating shoppers.

Out-of-town shoppers are "crucial" for a high-fashion shop, he says, making it almost imperative that such a business be in the downtown area.

A native of Spokane, Ferris attended Lewis and Clark high school and majored in economics at Harvard college. He worked for the J. C. Penney company here after graduation, then joined the army air force in December, 1941.

He spent three years in England and Italy as an air force administrative officer, and was a testmate for a time with the man who later was bombardier of the plane which dropped the first atomic bomb.

After the war he rejoined Penney's in Seattle. Then, at a party, he began a conversation with Eric A. Johnston, and the conversation resulted in Ferris' appointment as Washington, D. C., office manager of the Motion Picture Association of America.

In 1947, having "had enough of the big city and the bright lights," Ferris decided to return to Spokane.

Having decided that "merchandising is the one field I like," and not wanting to be trans-

ferred from Spokane, Ferris first met to work for the John W. Graham company.

Then, after seeing the Allen Salisbury "contemporary shop" in Seattle, Ferris decided that if such a shop could survive there, a similar one could in Spokane.

"Fortunately, we began business at the same time that the public was beginning to become interested in modern design," Ferris says.

Joel, Inc., which expanded its quarters three years ago, now is one of the oldest "contemporary shops" on the West Coast.

Besides doing interior design work and selling furniture, imported and domestic gifts and cards, Joel, Inc., provides an outlet for Spokane artists, selling, primarily, originals by Kathy, Lynn Gemberling and Harold Balaza.

"We like what we buy, and we buy what we like," Ferris says.
